



**Transforming Jail Ministries / Kenton County Detention Center
WAIVER, RELEASE AND INDEMNIFICATION AGREEMENT**

The undersigned participates in the Transforming Jail Ministries (TJM) program, including the Jail Chaplaincy Team, the Clergy Contact Visiting program, the Worship Team, or any other program associated with TJM. In consideration of and as a condition precedent to being allowed to participate in TJM activity in secure areas of jails serviced by the Kenton County Detention Center (TJM/KCDC activity), all TJM participants must read this WAIVER, release and indemnification agreement ("AGREEMENT"), agree to its terms, and indicate that acceptance and understanding by signing this Agreement. Refusal to sign this Agreement will preclude you from participating or taking part in TJM/KCDC activity.

With regard to any TJM/KCDC activity scheduled to take place at the Kenton County Detention Center at any time from and including the date I sign this Agreement through any time in the future that I continue to be involved in TJM/KCDC activities,

I hereby state that I understand and agree to the following:

If I participate in TJM/KCDC activity without having signed this Agreement, such participation will serve as constructive knowledge, acceptance, agreement and understanding of all terms and conditions contained herein.

I acknowledge and agree that by my participation in TJM/KCDC activity is for my own benefit and convenience, and I understand that I assume all risks in participating therein. I understand that the TJM/KCDC activity takes place in inherently dangerous areas and could potentially subject me physical injury to my person and/or damage to my personal property.

I understand that neither Kenton County, the Kenton County Fiscal Court, KCDC, Jailer Marc Fields ("the Jailer"), nor any employee, agent or representative of Kenton County or KCDC take any responsibility for providing personal protection of my person while engaged in TJM/KCDC activity. I understand and agree that Kenton County, the Board, KCDC Jailer or any employee, agent or representative of Kenton County or KCDC, make no warranties, express or implied, as to my personal safety, or as to my personal property while I am engaged in TJM/KCDC activity.



I understand and agree that Kenton County, the Fiscal Court, KCDC, the Jailer or any employee, agent or representative of Kenton County or KCDC, reserve the right to revoke my status as an approved visitor of the abovementioned facilities, with or without notice, with or without cause, and that I serve at the discretion of Kenton County, the Fiscal Court, KCDC, and the Kenton County Jailer.

Therefore, in consideration of being granted access to the secure areas of KCDC for participation in TJM/KCDC activities extended to me by KCDC, at the locations specified above, on any date that I am participating in such TJM/KCDC activity I, for myself, my heirs, executors, agents and assigns, hereby agree to hold Kenton County, the Fiscal Court, KCDC or the Jailer and Transforming Jail Ministries (TJM) its employees, agents and representatives harmless from liability for any injury to my person or damage to my property which may be suffered by me whether past, present or future, caused by my own acts or omissions, the acts or omissions of others, or other causes, and hereby waive, release, acquit and forever discharge Kenton County, the Fiscal Court, KCDC, the Jailer and any employees, agents, or representatives thereof, from any and all claims, liabilities, losses, demands or causes of action, of whatever nature, whether at law or in equity, including attorneys' fees, which I may now have, or which may hereafter accrue, arising out of any act, cause, omission or event, including but not limited to claims arising out of bodily injury or property damage that I may sustain while at the above-described premises or in connection with my use of those facilities, or in any other way or manner in connection with the above-described TJM/KCDC activity.

In further consideration of the foregoing; I hereby agree to and do indemnify and hold harmless Kenton County, the Fiscal Court, the Jailer and their employees, representatives, instructors and agents and Transforming Jail Ministries (TJM) its employees, agents and representatives, of and from any and all claims, liabilities, losses, demands or causes of action, of whatever nature, whether at law or in equity, which are or may be asserted by any person or entity, for personal injury, property damage or otherwise arising out of any actor omission by me in connection with my entry and use of the above described premises pertaining to TJM/KCDC activity.
